#### DISTINGUISHED CONTRIBUTION TO RESEARCH AWARD

#### Nancy File

The Early Education/Child Development SIG's Distinguished Contribution to Research Award is given annually by a committee of previous chairs of the SIG. This year the award goes to Dr. Nancy Barbour, Professor Emeritus, Kent State University.

Three words describing Nancy's career were echoed throughout her nomination letters. These are vision, leadership, and mentoring. As a result of this approach to her work, we see many examples of facilitating paths forward for individuals, institutions, and professional associations.

As described by Dr. Diane Horm, "It is rare to find an individual combining depth of content knowledge who is active in discipline-based research and demanding professional service activities with a successful university level administrative record." This administrative record includes 7 years as an associate dean at Kent State University. Nancy's professional service activities would consist of a veritable alphabet soup were acronyms to be used. Using full association names, Nancy has held major leadership roles in both the EE/CD SIG and the National Organization of Child Development Laboratory Schools. She has participated in the leadership of the National Association of Early Childhood Teacher Educators. Her multiple roles within the National Association for the Education of Young Children include important work on professional development of teachers and in accreditation of programs at both the AA and BS/BA levels. Finally, Nancy has been the leader within the United States for forming greater international relations with the European Early Childhood Education Research Association, serving as the U.S. country representative and a book series editor.

Nancy's many contributions to professional association work, as well as her scholarship, have contributed to how we envision and enact professional development within the field. Another area of contribution often associated with Nancy is her strong interest in child development laboratory schools. Her work has helped us to understand their history, as well establishing a vision regarding their ability to impact our field. According to Dr. Brent McBride, this interest has fueled "her belief that early childhood scholars need to situate their work in such a way as to make clear connections between theory, research and practice - an often overlooked perspective in our field." Throughout her career, Nancy has pursued applied research.

The work of Nancy's career has indeed been multi-faceted, including scholarship, leadership, and visioning. Establishing a record of contributions across so many venues and associations presents a commendable model of career impacts, and we are proud to present this 2020 Distinguished Contribution to Research Award to Nancy Barbour.

#### **EARLY CAREER AWARD**

#### Mary Jane Moran

This year's Early Career Award goes to Kate Delaney, Assistant professor at the time of nomination and recently promoted to Associate professor in 2020. Kate is an Associate Professor of Early Childhood and Special Education at the University of Toledo in Toledo, Ohio. Prior to this position, she completed a two-year post-doctoral fellowship at the University of Michigan, where she worked with Dr. Susan B. Neuman, exploring teacher practices around literacy interventions, as well as the scale up of universal pre-K (UPK) in New York City. She received her PhD from the University of Wisconsin-Madison in 2013. Her research largely focuses on relationships between early education policy (with a particular focus on public pre-Kindergarten and Head Start) and the lived experiences of teachers, children and families as they engage in program implementation and reforms. Congratulations, Kate on your award and recent promotion.

#### **OUTSTANDING DISSERTATION AWARD**

#### **Daniel Castner**

There were several exemplary dissertations nominated for the EE/CD Outstanding Dissertation Award, which made the committee's task quite challenging. After extensive deliberation, the committee selected Dr. Kathryn Boonstra's dissertation titled, First Time Out: An Ethnographic Multiple Case Study of Kindergarten Discipline as the recipient of the EE/CD Outstanding Dissertation Award. Dr. Boonstra is a graduate of the University of Wisconsin Madison, and her dissertation research was supported by her chair, Dr. Beth Graue. She conducted an ethnographic multiple case study of three kindergarten classrooms investigating how everyday disciplinary practices unfold intersecting with race, dis/ability, culture, and context. Reviewers applauded this work for addressing a complex and pressing issue with impressive methodological rigor, and praised the high quality of Boonstra's writing. One reviewer admired: "Her writing comes alive on the page and compels the reader to think beyond her words to experience what she, the teachers, and the children were experiencing". Congratulations Dr. Boonstra!

# Program Committee Report : 2020 Proposal Submissions Summary

#### **Total Submissions (n=232)**

This year we received a total of 207 Paper and 25 Session submissions. Of this total, 2 papers and 1 session were transferred to us from other SIGs. Based on information reported in previous SIG newsletters, <u>this represents</u> another new record.

#### **Deleted Submissions (n=2)**

Two paper submitters voluntarily deleted their submissions before we began the reviewer assignment process.

#### **Disqualified Submissions (n=2)**

We screened all of the submissions prior to assigning reviewers to ensure that they were:

- related in some way to our broad early childhood focus,
- blinded,
- met the 2,000 word limit (or roughly 5 single-spaced pages or 7 double-spaced pages), and
- appropriate for the session type to which the proposal was submitted.

As a result, we reached out to several submitters to correct their word limit issues. In addition, we had to
disqualify 2 session submissions that actually were a single paper. It should be noted that AERA does not
allow transfer between "format types," so this was our only option. However, we emailed both of these
presenters to explain why they submissions were being disqualified.

#### **Reviewed Submissions (n=228)**

We assigned 3 topic-relevant reviewers (and from our pool of 92 non-student volunteers) to each of the remaining 205 Paper submissions and 23 Session submissions. All of the reviewers were alerted about their assignments via bulk email on July 28, 2019.

#### **Conference Program Process**

AERA allotted the SIG a total of 18 paper sessions and 91 roundtables or posters. We set aside 8 sessions for individual papers (and with 6 papers each) and the remaining 10 for session (AKA symposia) proposals.

To determine whether to accept or reject a reviewed submission, we considered its overall average score and normalized scores (with the latter created by AERA to take into account inter-rater differences in scoring), as well as the reviewers' comments and their accept/reject recommendations. In the case of widely varying reviewer scores or comments, we carefully read the submission ourselves and in some cases "overruled" the outlier reviewer. Throughout this iterative process, our aim was to develop a program that reflected the many important topics facing our field and the different populations of scholars (e.g., early career vs. more experienced, academics working in institutions of higher learning vs. individuals affiliated with research organizations, etc.) that submitted proposals to the SIG.

Then, to determine whether an accepted submission was slotted as a paper, roundtable, or poster, we considered its focus and the extent to which we could group it with similarly focused proposals. Our final program contains:

- 139 paper submissions, for a 67% acceptance rate. This papers were presented as part of:
  - 8 Sessions (n=48)
  - o 10 Roundtables (n=35)
  - 4 Poster sessions (n=56)
- 10 session proposals, for an acceptance rate of 40%.

#### **Try-Try Again**

Something that I have experienced as a budding scholar is the process of rejection! I hope this goes without saying: rejection is part of the process. Remain optimistic, apply feedback, *and* consider reaching out to a peer reviewer throughout the writing process (see section above!). Sometimes it is useful to send just a few written pages and a few targeted questions to guide the peer review process. Prior to submission for the 2021 AERA conference, consider reaching out to a critical friend for support.

#### Network

Whether or not you are successful with your proposal, consider attending the AERA conference in 2021. Conference attendance (and membership in general) is an avenue for learning about universities and programs beyond what you have experienced. Just looking through the bios of our EE/CD board membership, there is such a variety! As you are on the verge of entering the field of higher education and/or educational research, it is important that you will be able to determine fit with your future institutional home.

#### **Job Search**

Something that I found to be useful while on the job search was paying attention to where my potential colleagues earned their doctoral degrees, where they have published, and the conferences they have presented at. Perhaps, surprisingly (due to the size and institution type), at the small liberal arts college that I hope to find a home at, all of my potential colleagues are very active in their scholarship and attend AERA regularly. This is a perfect fit for me. I look forward to seeing you all at AERA annual meetings for many years to come!
